Plans & Design Proposals & Insurance

For Custom-built Participation Exhibitors, Form 1 (Custom-built Participation Contractors' Information), construction drawings, site work deposit and a copy of valid public liability insurance should reach Mr Abel Kwan (abel.kwan@hktdc.org) / Mr Aston Fong (aston.wh.fong@hktdc.org), Exhibition Services Department, Hong Kong Trade Development Council no later than 22 July 2022. Otherwise, a late charge of HK\$3,000 (US\$400) will be charged to the Exhibitor or its appointed contractor.

Drawings submitted must be in reasonable scale of at least 1:100, fully dimensioned and must contain information such as floor plan, stand elevation, electrical fittings, carpeting, colours and materials to be used, moving exhibits, audio-visual equipment, weights and point loading of exhibits etc. Any alterations after drawing submission should be addressed to the Organiser for review.

Submission of drawings:

- Booth construction height below 4.5m → Submission via email to the Organiser
- 2. Booth construction height at 4.5m or above → <u>Submit 4 copies of drawings with structural calculations endorsed by an Authorized Person/Registered Structural Engineer (AP/RSE)</u> to the Organiser. The Organiser will keep 1 copy for review, pass 1 copy to Venue Operator for record and submit 2 copies to Director of Food & Environmental Hygiene at least <u>42 days before</u> first show day for further distribution to Fire Services Department and Buildings Department for review.

<u>Pursuant to Electronic Transactions (Exclusion) Order made under Section 11(1) of the Electronic Transaction Ordinance (1 of 2000), the Director will not accept any electronic submission of plans.</u>

Site Work Deposit

Exhibitors/Contractors of Custom-built participation are required to lodge a site work deposit of which will be collected based on HK\$300/US\$40 per sqm. For two-storey construction stand, site work deposit is doubled. However, the HK\$75,000 (US\$10,000) respectively.

All deposits will be <u>bank-in</u> and the amount will be refunded within <u>TWO months</u> after conclusion of the Fair if their exhibition sites are, in the Organiser's view, clear of damage to the exhibition hall and all rubbish are cleared according to the time schedule of the Organiser and without violating the conditions as stipulated under section 4.2.15 of Exhibitors' Manual. Otherwise, costs incurred by the Organiser will be deducted from the deposit.
